

Who may qualify for the Emergency Housing Voucher

Program?

Emergency Housing Vouchers (EHVs) are specifically designed for households who are:

1) Homeless; 2) At Risk of Homelessness; 3) Fleeing or attempting to flee domestic violence, dating violence, sexual assault, stalking or human trafficking 4) Recently homeless and for whom providing rental assistance will prevent the family's homelessness or having high risk of housing instability.

How do I apply?

Direct referrals for EHVs may only come from the Yuma County CoC's CE System

Eligibility

Upon referral from CoCs HACY will then determine eligibility to EHV based on HUD eligibility guidelines.

1) Intake Appointment- Review & Certify families eligibility 2) Voucher Issuance 3) Confirm the unit is eligible 4) Determine that the rent being charged is reasonable in accordance with the standards established 5) Determine the unit meets the Housing Quality Standards (HQS) set by HUD 6) Family establishes a new lease and moves in to unit.
