Approval of Board Minutes

C. Jerpseth moved to approve the minutes of October 17, 2023 and C. Jersepth seconded the motion. The minutes were unanimously approved.

Executive Director's Report

On The Cover

FSS Graduate

Michelle Arcinega successfully completed her goals and recently graduated from the FSS Program. She is currently employed as a Probation Drug Court Surveillance Officer.

2023 Christmas Spirit Crew

HACY staff spread goodwill and holiday cheer by decorating the main office and our various community centers for the 2023 holiday season.

General

We continue to improve Yardi Systems, and are working through an action plan to strengthen utilization of the system, streamline operations, improve customer service, and reduce costs.

Pilkington Construction Company is still working through a fire suppression re-design to address COY concerns related to the planned triplex on Maple Avenue. We hope to have COY approval by end of next week. PCC is prepared to begin construction by end of month.

We recently updated plans for the proposed Magnolia Gardens project. We hope to construct 12 units of affordable housing. The COY is working through details with a HUD consultant to confirm total grant availability and approval our budget proposal.

We are working with Nomar Properties to complete the lot tie – lot split on 18th Street and Arizona Avenue property to address the right-of-way issue, and will soon submit revised design plans incorporating COY recommended improvements for the Mesa Heights Village.

We are working with the COY to assist in efforts in replacing roofs, upgrading parking, and potentially add a shade structure at the Mesa Heights Pueblos. We are waiting for city direction and project-budget authority.

The Yuma Valley Contractors were selected to complete the renovation of our HACY Home to prepare it to serve as our Prosperity Business and Learning Center.

We are currently working on AWC-accredited curriculum in Entrepreneurship for the PBLC, and we are working with the AWC Entrepreneurial College and Arizona at Work to create additional programming and certifications to offer our community through the PBLC.

A Purchase and Sale Agreement for the Casa Sierra Vista Apartments was recently signed. We are currently working with HUD to effectively transfer the physical asset as soon as possible.

SHINE Mentor Leaders completed the MGT 280 Leadership course this fall and will complete BUA 210 Customer Service Management and BUA 100 Survey of Business this spring.

Section 8 Program

Section 8 currently has 1,584 units under lease (109% Lease-up). There were 0 briefings completed, 0 vouchers issued, 0 outstanding vouchers, and 1 new (RAD) contract for the month. Staff completed 102 Annual Re-Exams, 132 Interims, and 13 Unit Transfers. There were 4 Section 8 residents terminated from the Section 8 Program for various reasons. There were 183 unit inspections.

HACY Housing / Property Management

There were 2 move-outs from HACY Housing this month. The average length of time to turnover a unit year-to-date is 51 days.

Staff collected 93% of rent billed this month. The HACY Housing YTD delinquency is \$4,274.

Maintenance

There were 116 total work orders issued and 62 completed this month. There were 18 emergency work orders of which 18 were completed after hours. Maintenance completed turnover of 2 units.

Community Services

We currently have 237 active participants in the FSS Program. There were 0 home-ownership closing this month. We have 1 homeowner year-to-date.
